CONCLUSIONS: With the precautions indicated, by the risk assessment, the concert, workshop and sessions can take place with minimal risk.

NOTES:

- 1. This assessment reflects the full range of risks FluteFling audiences, tutors, participants, volunteers and performers may exposed to during the concert and workshops associated the event. It including risks associated with viral respiratory diseases and the precautions required to manage risk to an acceptable level.
- 2. At the time this risk assessment was prepared the Scottish Government website confirms there are no COVID rules or restrictions in Scotland and that COVID threat levels are not currently in use.
- 3. Currently the HSE website indicates that the HSE no longer expects every organisation to consider COVID-19 in their risk assessment or to have specific measures in place.
- 4. The Public Health Scotland information on viral respiratory diseases (including COVID 19 and Influenza), published on 06 March 2025 confirms that infections are currently at baseline levels.



- 20 Theatre Layout - 15 Group Meeting layout.








Anchor West – Workshop & presentation venue. The room measures 120m² and has a maximum capacity of 80

Appendix 3: Victoria Hall Concert Seating Layout


